DEATH PENALTY:

Arizona law provides for the possibility of three phases to a trial in which the death penalty may be an issue. This means there may be three "trials" in this case. In the first trial, the jury must decide whether the prosecutor has proven all the elements of first-degree murder beyond a reasonable doubt. If the prosecutor proves all of the elements of first-degree murder in the first phase, there will be a second trial. In the second trial, it is necessary that the prosecutor must prove beyond a reasonable doubt the existence of an additional factor that makes a person eligible for the death penalty. In the event that the prosecutor proves the necessary elements to your individual satisfaction in each of the first two phases, there will be a third trial. In that trial, you will be required to decide whether to impose a death sentence or a sentence of life imprisonment.

In any case in which the death penalty is a possible punishment, the law requires that prospective jurors answer questions regarding their thoughts, feelings and opinions on the death penalty. The law requires these questions be asked before a person has been found guilty. You must not assume from any of the questions asked that any defendant is in fact guilty of any crime.
